FROM THE NORTH (Pennsylvania)

1. Take I-95 South to I-676 West (Vine Street Expressway) to Broad Street Exit.
2. The Broad Street Exit will take you to 15th Street.
3. Continue straight on 15th Street to Locust Street.
4. Take a left on Locust Street. The Academy House will be on your right. The parking garage will be on your left.

FROM THE NORTH (New Jersey)

1. Take NJ Turnpike to Exit 4.
2. Take Rt. 73 North to Rt. 38 West.
3. Follow Rt. 38 West to US 30 West.
4. Follow US 30 West over Ben Franklin Bridge into Pennsylvania.
5. Follow signs for Central Philadelphia - Vine Street.
6. Turn left onto 15th Street. Travel South on 15th Street.
7. Take a left on Locust Street. The Academy House will be on your right. The parking garage will be on your left.

FROM THE SOUTH

1. Take I-95 North to I-676 West (Vine Street Expressway) following signs for Central Philadelphia.
2. Follow I-676-West to Broad Street/15th Street Exit.
3. Travel south on 15th Street.
4. Take a left on Locust Street. The Academy House will be on your right. The parking garage will be on your left.

FROM THE WEST

1. Take I-76 (Pa. Turnpike) East to I-76 (Schuylkill Expwy).
2. Take Schuylkill Expwy. (I-76) East to Central Philadelphia-Vine Street Exit (exit to left).
3. Take Vine Street to 15th Street, turn right.
4. Travel south on 15th Street.
5. Take a left on Locust Street. The Academy House will be on your right. The parking garage will be on your left.

1. Take Rt. 70-30 West to Ben Franklin Bridge.
2. Follow signs to Central Philadelphia-Vine Street.
3. Turn left onto 15th Street.
4. Travel south on 15th Street.
5. Take a left on Locust Street. The Academy House will be on your right. The parking garage will be on your left.
